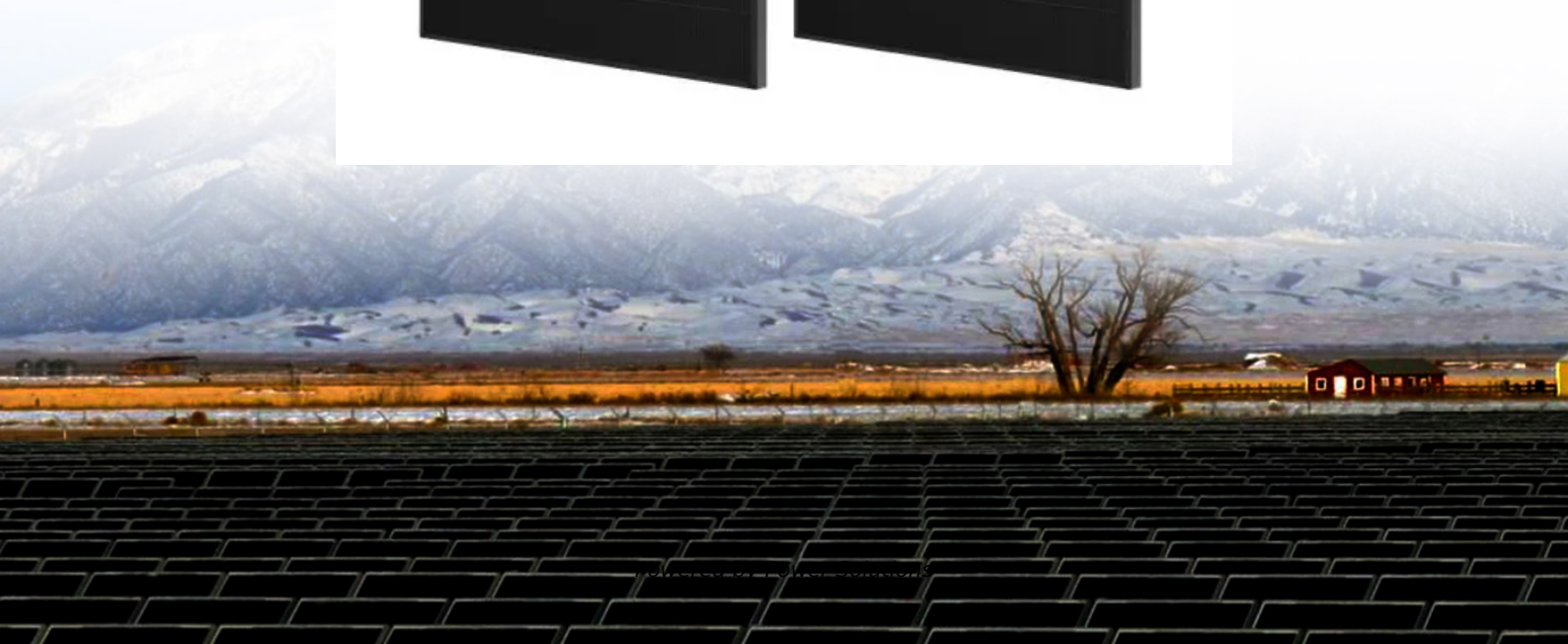


How long does it take to get approval for solar container station construction
